Adobe Creative Cloud (Adobe CC) Applications include;

Please be advised, the Adobe CC package includes cloud storage which is stored in the United States. We will advise students and staff to save their work on the Microsoft Office 365 OneDrive servers, which are hosted in Canada.

Your consent is required by British Columbia's *Freedom of Information and Protection of Privacy Act (FIPPA)* prior to providing your child with an Adobe CC license.

To assign an Adobe CC license, your child's personal information will be shared to enable registration with Adobe and be provided with the Adobe CC package license. The following personal information is shared from the VSB to Adobe CC.

- First name
- Last name
- VSB provided email address
- Country of residence

Upon registration, VSB email address and country of residence will be stored on Adobe servers. While stored outside the country, information may be subject to the laws of foreign jurisdictions, including, in the United States, the USA Patriot Act.

If you choose not to provide your consent, your child will not be penalized in any way and alternate activities will be provided as appropriate. If you have concerns about the use of Adobe CC, please speak directly with

your child's teacher.
